- In accordance with the criteria foreseen in the competition announcement for student enrolment in FSP for the academic year 2018-2019, successful candidates are obliged to conclude a contract for the return of investments with the respective institution. Prior to the conclusion of the contract, the list of successful candidates is sent to the relevant agencies to verify whether any of the candidates has a disciplinary and criminal record as a condition of concluding a contract.

The successful candidate according to the record of results that has a disciplinary or criminal record can not be enrolled in the Faculty of Public Safety and the vacancy is filled in order within the sub-quota with the next successful candidate. In cases where there is no successful candidate within the ranks, will be fulfilled with the candidate who has the most points within the total quota of the agency concerned.

Also in the agencies that did not meet the quota (Customs and AME), the Board agreed to announce the additional competition for the purpose of meeting the quota.
